#### **GFWC WEST VIRGINIA SCHOLARSHIP FUND RULES**

#### **APPLICATION DEADLINE APRIL 1, 2014**

- The recipient of a scholarship shall be a man or woman who is a United States
   Citizen and has resided in West Virginia for at least three years prior to applying.
- A scholarship of up to \$1,000 will be available. Funds exceeding \$500 will be sent in two (2) payments. The first \$500 will be sent prior to <u>June 1st</u>. The second \$500 will be sent prior to <u>February 1st</u>, <u>ONLY</u> when the student <u>provides</u> a transcript of the first semester completed, a letter of acceptance and class schedule for the second semester.
- Only <u>one</u> scholarship will be granted to an applicant in a calendar year. Applicants
  may apply each year they are attending school. A new completed application is required.
- 4. Scholarships will be granted for attending an accredited college, professional, vocational or technical program offered by an institution in West Virginia. Students must be full-time students. Scholarships may be granted for attending a school or college outside West Virginia only if the course desired is not offered within the state.
- 5. Applications shall be <u>sent directly to the District Representative</u> in the District where you live. The name and address of your district representative appears on the left side of this paper. If your district is unknown, please call Chairman B. Potoczny.
- The applicant shall submit, with the application, The following requirements for eligibility:
  - A. Two (2) current letters of recommendation
    - one personal
    - one scholastic
    - B. A recent transcript of grades
  - C. Copy of letter of Acceptance or Validation from the accredited School to be attended
- Completed applications with <u>all</u> elements <u>must be</u> postmarked by <u>April 1<sup>st</sup></u>.
   Applicants will be notified as to the action of the Scholarship Fund Board. The amount of the scholarship will be <u>paid directly to the applicant</u>.
